## **ALLOWANCE FOR FAMILY UNITS WITH THREE UNDER-AGED CHILDREN, AT LEAST**

(in compliance with Law 448 23.12.1998, art. 65 and its consecutive amendments)

### **1) Preliminaries**

According to the data supplied by the Municipality, INPS allocates monthly allowances (up to 13 months) as financial backing to family units with three under-aged children, at least.

For the year 2019, Department of Labour and Social Security (refer to Official Gazette no. 82 dated 06/04/2019) has set the monthly allowance at € **144.42** (granted for 13 months if awarded at the whole amount) starting from January, 1<sup>st</sup> 2019.

### **2) Who is entitled to ask for a Family Unit Allowance contribution:**

- Italian and/or European Union Citizen;
- Non-EU citizens who have been living in Italy regularly for 5 years minimum; relatives of non-EU citizens holding a Residence Permission; foreign citizens with political refugee status or other status specified by the law.
- Citizen with residence in the Municipal Territory
- Under-aged children (less than 18 years old) in a number of three as a minimum **must** be registered in the personal data file of the parent presenting the Application, regardless they are natively part of the parent family or its/her consort children or children in pre-adoptive care. The registration must be granted for the whole period of the Allowance allocation.
- ISEE family unit income (easy terms conditions for under-aged children) calculated according to the DPCM 159/2013 and its subsequent amendments, must not be beyond the threshold set by ISTAT, up-to-dated annually.

For the year 2019, ISEE threshold is set to € **8,745.26**.

### **3) Time frame in which applications must be presented**

Applications must be presented not later than January, 31<sup>st</sup> 2020.

### **4) Notes and recommendation**

- ISEE Certification is released by a Fiscal Assistance Centre (CAF) or by a Trade-Union Organization
- Financial Police shall operate investigations on applications with an ISEE figure set to 0.
- Applications must be done filling the specific form and forwarded to Servizio CerviaInforma Cittadini, Viale Roma 33 (phone 0544.979350) with ISEE Certification, attached.
